- 3) Brookfield Asset Management Inc. changed its name from Brascan Corp. on November 10, 2005.
- 4) Canetic Resources Trust changed its name from Acclaim Energy Trust in 2005.
- 5) Catalyst Paper Corp. changed its name from Norske Skog Canada Ltd. on October 3, 2005.
