

ADDENDUM NOTES

1. Abbott Laboratories verified that it does not have a Canadian board of directors.
2. ATI Technologies was acquired by Advanced Micro Devices Inc. (AMD) and is represented by AMD's board of directors.
3. The Atlantic Lottery Corporation board Chair is not part of the board, but was hired as an independent.
4. Atlas Cold Storage Income Trust was acquired by Avion Group, a privately held foreign company, in 2006 and no longer has a Canadian board of directors.
5. BJ Services Company Canada verified that it does not have a Canadian board of directors.
6. Boeing Canada Inc. verified that it does not have a Canadian board of directors.
7. British Columbia Liquor Distribution Branch is an arm of the BC government, which reports to a Minister, and does not have a board of directors.
8. Burlington Resources Canada Ltd. was acquired by ConocoPhillips Canada Resource Corp. and is represented by ConocoPhillips' board of directors.
9. Cambior Inc. merged with IAMGOLD Corp.
10. CI Financial's name changed to *CI Financial Income Fund*.
11. Coca-Cola Beverages Ltd. does not have a Canadian board of directors and their name is *Coca-Cola Bottling Company*.
12. Coopérative Fédérée du Québec's name has changed to *La Coop Fédérée*.
13. Creo Inc. was acquired by Eastman Kodak in 2004 and there is no longer a Creo Board of Directors.
14. Energem Resources Inc. is an African company with no presence in Canada and no Canadian Board of Directors.
15. Entertainment One Income Fund verified that there is no longer a Canadian board of directors. Entertainment One's Canadian and US operations were sold on March 29 2007 to Entertainment One Ltd., a UK based equity firm. All of the existing trustees of Entertainment One resigned as trustees and directors of Entertainment One and its subsidiaries.
16. Fairmont Hotels & Resorts Inc. is no longer a Canadian company, therefore no longer has a Canadian Board of Directors.
17. Falconbridge was acquired by XSTRATA and no longer has a Canadian Board of Directors.

30. Oracle Corporation Canada Inc. does not have a Canadian Board of Directors.
31. Parmalat Canada Ltd.'s name is Parmalat Dairy & Bakery Inc.
32. Royal Group Technologies Ltd. was taken over by an American company, Georgia Gulf and no longer has a Canadian Board of Directors.
33. Smucker Foods of Canada verified that it does not have a Canadian Board of Directors.
34. State Farm Verified that it does not have a Canadian Board of Directors.
35. Terasen Inc. was acquired and at the time of verification had no Canadian Board of Directors.
36. Textron Canada Ltd. was bought in 2001 by Collins and Aikman, an American company and no longer has a Canadian Board of Directors.
